'02 Grad and Attorney Dan Desmond to present Barley Snyder-Sponsored Scholarship to McCaskey High School Senior

In addition to the scholarship, Dan has presented at career and education discussions at the high school and recently hosted a group of students at Barley Snyder to discuss the legal profession and law school with attorneys and paralegals from the firm.

The Lancaster Education Foundation was established in 1989 to promote educational excellence in the School District of Lancaster in areas of technology and learning, scholastic enrichment, arts and education, careers and vocations and cultural enrichment.
