NCR is based in New Freedom, Pennsylvania and offers historical, educational, and entertaining railroad excursions. Founders [William H. Simpson and D. 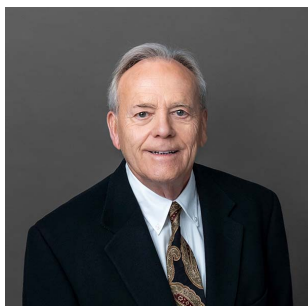
