Reading, Pa. - Barley Snyder has consolidated two of its offices in Berks County to operate in one expanded location. The firm's [Century Boulevard office](#) recently underwent renovations to enlarge and enhance the space. Professionals from the firm's downtown Reading office, located at 50 North 5th Street, will relocate to the Century Boulevard office which became part of the Barley Snyder footprint in 2022 when the then Leisawitz Heller firm joined Barley Snyder. The expanded space will house a total of 29 attorneys, 15 paralegals and 16 additional staff.

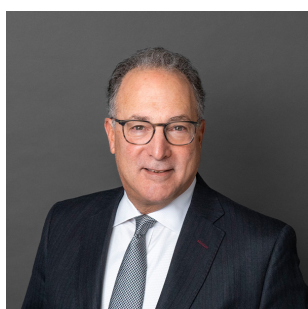
