OVERVIEW:

Don is the chair of the firm's [Cybersecurity Service Team](#) and a member of the Finance & Creditors' Rights Practice Group. He also serves on the firm's technology committee and as the firm's Chief Privacy Officer.

Don first became involved in cybersecurity initiatives while he was a law clerk with the Office of Naval Research, U. S. Department of the Navy, in the late 1990s.
