#### Real Estate and Land Use

Keith represents both municipal and development clients in matters involving requests for variances, special exceptions, conditional uses, zoning appeals and other land use issues. He has drafted amendments to zoning ordinances and guided municipalities through the amendment process mandated by the [Pennsylvania Municipalities Planning Code](#), and assists municipalities and developers in guiding real estate development projects through the subdivision and land development process. Keith regularly works with residential housing and retail/commercial developers, convenience store/gas station chains, fast-food franchises (on both the franchisee and franchisor side), and big-box warehouse operators.

Projects in which Keith has assisted the Redevelopment Authority with include the [Goggleworks Center for the Arts](#), the City of Reading Sovereign Center and the R/C Theatres project, which involved the development

of an eleven-screen multiplex including an IMAX theatre.
