Megan was an active member of the Lebanon County Child Abuse Task Force and a board member representing Lebanon County for the Children's Resource Center in Harrisburg. She was appointed by the Lebanon County Court of Common Pleas as a Custody Conciliator, a role which she served in from June 2003 to January 2023, resolving familial custody issues in lieu of litigation.

Outside of the firm, Megan is involved with Leadership Lebanon Valley's Justice Day Program volunteering with its mock trial and providing a presentation about the criminal system. She also serves on the boards of the Lebanon Community Library, the Salvation Army Lebanon Corps and the Lebanon County Bar Association.
