



#### Cybersecurity Chair: Donald Geiter

With the rise in the widespread use of technology, cybersecurity has become a critical element for any business. Partner Donald Geiter led the effort to form a Barley Snyder Cybersecurity Service Team that helps answer the increased volume of legal questions flowing into the firm concerning network protection and data breach response. In 2019, Geiter received a Master of Studies in Law degree (Cybersecurity Law and Policy) from the University of Maryland's Carey School of Law, bringing up-to-date educational credibility to his real-world experience in helping companies protect some of their most important assets – their information assets, computer infrastructure and network. 
#### Justin Tomevi - Named Partner

# WORKING for OUR CLIENTS

#### TIGER CAPITAL

When national retailer The Bon-Ton Stores closed its doors in 2018, it left about 260 large, vacant stores across its footprint, some of which were owned by the department store chain. New York City-based Tiger Capital, part of a joint venture which purchased the rights to sell dozens of the then-empty Bon-Tons, looked to Barley Snyder for help in selling those buildings. With our firm's assistance from attorneys Reilly Noetzel, Abby Tucker, Sarah Yocum Rider and Maria Di Stravolo Elliott, Tiger Capital sold seven of the stores the company owned, including The Bon-Ton Stores and other Bon-Ton-owned outparcels in Camp Hill, Pa. Many of the new owners of the buildings already have designed future uses for the buildings. The Bon-Ton's former Camp Hill location, which also included a shuttered Border's location, has been demolished to make way for a new hotel, restaurant and retail shops planned to open in 2021.

#### **CYBERSECURITY**

It's a nightmare scenario for companies in today's technology world. They're alerted that their system has been fraudulently compromised, and hundreds of thousands of dollars are missing. It happened to a Barley client in 2019, and the client's initial prognosis wasn't good to recoup any of the lost funds that reached nearly seven figures. However, the client contacted partner Tom Nehilla, who quickly fed the pertinent details to partner Don Geiter, the chair of our Cybersecurity Service Team. Geiter immediately went to work getting in touch with authorities and investigations contacts, and making claims against third parties alleged to have been partially responsible for the compromise. Geiter orchestrated a recovery for the client within several weeks of the compromise that accounted for nearly 90% of the compromised funds - including funds the client initially believed to be gone forever.







#### PATENT HARMONIZATION

Did you know that the five major patent-issuing entities around the globe all have different rules for a business or inventor to procure a patent? That forces businesses looking to sell their new product in international markets to go through the rigors of patent approval five different times. Partner Salvatore Anastasi, the chair of our Intellectual Property Practice Group, is a member of the American Intellectual Property Law Association (AIPLA) Patent Harmonization Committee and has traveled across the globe in 2019 working to create procedural and substantive harmonization among global patenting systems. His stops in 2019 have included London and South Korea. Making these patent approval processes more similar will help businesses get their products to market faster.





# FIGHTING FOR HEALTH CARE PROVIDERS

The Pennsylvania Bar Association selected Katherine Kravitz, the chair of our Health Care Industry Group, to testify before the Pennsylvania Legislative Budget and Finance Committee regarding a potentially volatile rule change being contemplated by the Pennsylvania Supreme Court. The change would revoke the current rule, which requires plaintiffs in medical malpractice cases to file their lawsuits in the county where the alleged negligence occurred. In the current health care environment, where integrated health systems are an important part of ensuring access to quality health care for all Pennsylvanians, repealing the rule would allow plaintiffs to "shop" their cases to counties where jury awards are historically highest, forcing health care providers to litigate cases in foreign, higher-risk venues. Kathy advocated against this change, presenting evidence that the rule was needed to prevent a recurrence of the medical malpractice insurance crisis of the late 1990s which resulted in skyrocketing insurance costs and an exodus of doctors from Pennsylvania. Kathy was the only attorney selected by the bar association to present the defense side of this issue to the committee. Since Kravitz's testimony in June, there has been no movement on the rule change.





# LITIGATION VICTORIES

Our litigators aggressively defend our clients:

#### **Business Litigation**

Stephanie DiVittore and Lindsey Cook represented a California corporation which entered into a series of large equipment leases with several related companies. When the lessees defaulted on payments under the lease agreements, the company filed suit in California and obtained a default judgment against the related companies and the individual owners of the companies. The company transferred the judgment to Pennsylvania, the location of the defendants, for execution proceedings. One of the corporate defendants and its owner filed a petition to strike the judgment, contending that the California court lacked personal jurisdiction over them. The trial court denied the petition, and that decision was appealed. The Pennsylvania Superior Court, after briefing and oral argument, determined that the foreign judgment was, in fact, entitled to full faith and credit with respect to the appellants. The Superior Court determined that the lower court properly determined that the California court had specific jurisdiction over the appellants. It upheld the determination that, per the effects test, appellants purposefully availed themselves of California's benefits, the California action was related to appellants' contacts with California and the exercise of jurisdiction comported with fair pay and substantial justice as required by the Due Process Clause of the 14th Amendment to the U.S. Constitution.

## Commercial Litigation

**Justin Tomevi** represented a minority shareholder in a manufacturing organization. The minority shareholder was concerned about the lack of information the majority shareholder was sharing regarding the business operations and had concerns about the financial condition of the business. Justin conducted an investigation of the corporate records and financials and discovered that almost \$400,000 had been improperly withheld from the entity for which Justin's client owned an interest. Instead, the majority shareholder retained the funds in separate entities which he controlled and was using those funds for his personal expenses. Justin negotiated the repayment of 100% of the amount owed to his minority shareholder client, plus interest. Justin also negotiated the purchase of his client's interest in the company at an above market valuation and secured a generous severance package for the client to be able to retire from the company.

## **Employment Litigation**

**Michael Crocenzi** successfully defended a regional architectural and engineering company in federal court. A former employee of the company sued claiming violations of the Americans with Disabilities Act, the Family and Medical Leave Act, the Genetic Information Nondiscrimination Act, the Pennsylvania Human Relations Act and Title VII (sex discrimination). Mike successfully convinced the federal judge that there was no basis for these multiple claims and the judge dismissed the case before trial.

#### Fiduciary Litigation

**Justin Tomevi** represented two beneficiaries of their late aunt's estate. The beneficiaries' aunt passed away in 2005, but the estate administration was delayed for over a decade by the executor of the estate. The beneficiaries asked Justin to investigate when their proposed distributions seemed to be far less than anticipated. When Justin's initial demand for information on the finances of the estate was ignored, Justin initiated an accounting action in the Lebanon County Court of Common Pleas' Orphan's Court Division. After having the court-ordered production of the finances, Justin uncovered that nearly \$300,000 had been misappropriated by the executor and used to fund the executor's business for the past decade. Justin negotiated the immediate return of 100% of the misappropriated funds at a heightened interest rate and payment by the executor of all attorney's fees and court costs incurred in uncovering the misappropriation. The total amount recovered by Justin's clients totaled nearly \$500,000.

#### **Intellectual Property**

In 2018, **Salvatore Anastasi** and **Joshua Schwartz** were instrumental in authoring an American Bar Association amicus brief filed in a U.S. Court of Appeals for the Federal Circuit patent case that will ensure "access to justice," a core principle of the ABA. In 2019, the case made it to the U.S. Supreme Court, and the Court agreed with the Barley team's original premise, that the U.S. Patent and Trademark Office should not collect attorney fees in certain appeals cases.

#### **Landlord-Tenant Matters**

**Joshua Knapp** successfully prosecuted an emergency injunction petition for his landlord client. The court imposed restrictions on potentially disruptive behaviors and limited the tenant's rights to possess firearms on the landlord's property.

#### Medical Malpractice

In a nearly two-week trial, **Lauralee Baker** and her team successfully defended a pediatrician who allegedly missed a bowel abnormality in a newborn child that led to a bowel rupture, bowel resection and ostomy placement. Despite being called to testify over four days of the trial, the pediatrician remained consistent and credible. Defense experts from Massachusetts, Florida and Pennsylvania further bolstered the pediatrician's testimony to ultimately convince the jury that the standard of care was met in the treatment of this child.

# Medical Non-compete

**David Freedman** and **David Walker** convinced the Adams County Court of Common Pleas to enter a permanent injunction preventing an endocrinologist formerly employed by our client from setting up a nearby competing practice. The endocrinologist appealed the decision to the Pennsylvania Superior Court, but the Superior Court dismissed the appeal. Freedman also teamed with **Erica Townes** to convince the York County Court of Common Pleas to reject a former employee's request for a preliminary injunction that would have permitted our client's former employee, a neurosurgeon, to work for a competing health care system in violation of the neurosurgeon's non-competition agreement with our client.

#### Municipal Zoning and Pennsylvania Supreme Court

Pennsylvania's Supreme Court set an important precedent in 2019 when it agreed with Matthew Hennesy's argument in a long-running case that will have a significant positive impact for animal agricultural operations throughout Pennsylvania. The case began when Michael Davis successfully assisted a property owner near Bloomsburg in receiving a special exception from a municipal zoning hearing board to build a swine nursery barn. Local residents appealed the special exception, arguing that the barn was prohibited by local zoning regulations that were stricter than the statewide regulations in the Nutrient Management Act that apply to the largest, most intense animal operations. The case took on statewide focus because the outcome potentially impacted thousands of Pennsylvania farmers who faced the prospect of stringent local regulation or meeting the regulatory requirements imposed on the largest animal operations. Hennesy convinced the Pennsylvania Supreme Court that Pennsylvania's Nutrient Management Act prevented municipalities from imposing upon small agricultural operations standards that were more burdensome than those applied to larger operations under the act.

# Non-compete Contracts

Joshua Knapp successfully represented a full-service drilling contractor and several of its employees on appeal before the Superior Court of Pennsylvania in a non-competition and misappropriation of trade secrets case brought by the employees' former employer. The Superior Court of Pennsylvania affirmed the trial court's complete denial of preliminary injunctive relief, noting that the case presented a factually and procedurally complex history and concerned the interaction between contractual restrictive covenants and relevant provisions of the Pennsylvania Uniform Trade Secrets Act. At the trial court level, Joshua first obtained the denial of emergency injunctive relief, then the complete denial of preliminary injunctive relief after extensive discovery and evidentiary hearing. Jill Welch also successfully secured a preliminary injunction for a medical supply manufacturer seeking to enforce a non-compete, non-solicitation and confidentiality agreement in the York County Court of Common Pleas against a former national sales director working for a competitor.

#### Shareholder Litigation

Justin Tomevi and Christopher Naylor represented a shareholder of a construction company in a complex shareholder dispute. The shareholder owned 50% of the company with his co-owner, who passed away unexpectedly. The co-owner controlled the finances of the company and had brought the company to the brink of financial insolvency due to poor decision making. Despite this, the shareholder agreement permitted the coowner's estate to receive \$2 million from a key man life insurance policy. By alleging fiduciary duty breaches by the co-owner, Justin and Chris negotiated for their client to receive \$500,000 of the key man life insurance policy to reinvest in turning around the company. Several months later, the shareholder was able to return the company to profitability.

#### Tax Exemption Litigation

Justin Tomevi and Christopher Naylor represented a faith-based non-profit organization in York County when a local school district challenged the organization's tax exempt status. The school district challenged the organization's exemption based on allegations that the organization competed with for-profit organizations for certain services. Justin and Chris ultimately convinced the school district to withdraw its challenge, which resulted in the return to the organization of over \$100,000 in taxes.
